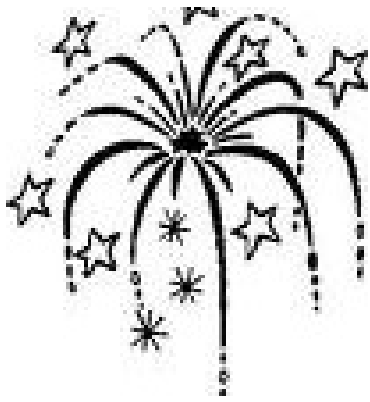

Contact the West Milford Board of Health Department at (973) 728-2720 and the West Milford Fire Department at (973) 728-2840 to obtain the necessary guidelines and applications. **YOU ARE RESPONSIBLE FOR OBTAINING ALL NECESSARY PERMITS!**
